For all purposes listed in this contract, PAINTED LADY will take as its cancellation date, the date and time stamped on the email given as notice of cancellation.

### CHANGES, ADDITIONS, STIPULATIONS

Any changes, additions, stipulations or deletions including corrective lining out by either PAINTED LADY or CLIENT(S) will not be considered agreed to or binding on the other unless such modifications have been initialed or otherwise approved in writing by the other.

### **INDEMNIFICATION**

Client(s) shall indemnify and hold harmless PAINTED LADY, their affiliates, agents, employees, officers, directors, and assigns from and against any and all claims, demands, penalties, fines, liabilities, settlements, damages, costs and/or expenses of any kind or nature, including legal fees and expenses for expert witnesses and consultants, arising out of or in any way connected

with CLIENT(S) occupancy or use of, and activities at the property under the terms of this agreement, unless the claims are based on the intentional or gross negligent acts or omissions of PAINTED LADY.

### **COLLECTION EXPENSES**

CLIENT(S) shall be responsible for payment of collection costs, attorney's fees, and interest associated with the PAINTED LADY effort to collect monies owed under the terms of this Agreement.

### **EVENT INSURANCE**

Client must obtain a special event liability policy designed to protect the event hosts (and list PAINTED LADY as additional insured) in the event of any liabilities or property damage that occurs on the day of the event. Those policies for a standard wedding (under 150 attendees, host liquor included, \$1M/\$2M limits) cost approximately \$120.

### **EVENT DURATION**

Clients will have exclusive use of PAINTED LADY event facilities for time specified in this contract. Prior to the start time, there may be other activities underway at the property. As this is a lodging establishment, certain lodging activities may take place during events (i.e., guests checking in, moving about the property, etc.).

**Begin Time** – The begin/set-up time for an event begins at **Noon** on the day of the event. If lodging rooms are included, **check-in is at 4:00 p.m**. Check-out time for lodging guests is Noon the following day.

**End Time** – All events must end no later than **10:00 p.m.** or at the agreed upon time. This means that guests must be making a reasonable attempt to vacate the property by **10** p.m. All items and decorations must be collected and the property returned to normal by **Noon** the following day.

### **REHEARSAL**

Clients may conduct a rehearsal (if needed) on site with prior scheduling. Rehearsals are allotted one hour from start to finish. Please ask participants to arrive on property no earlier than 10 minutes before rehearsal start and leave no more than 10 minutes after rehearsal end time. PAINTED LADY reserves the right to require that all vendors and guests leave the grounds at the contracted time.

### **DAMAGE TO FUNCTION SPACE**

CLIENT(S) agree to pay for any damage to the function space that occurs while CLIENT(S) are using it. CLIENT(S) will not be responsible, however, for ordinary wear and tear or for damage that it can show was caused by persons other than CLIENT(S) and event attendees.

### **IN-HOUSE EQUIPMENT**

PAINTED LADY will provide at no charge to CLIENT(S): tables and chairs. These complimentary arrangements do not include special setups or extraordinary formats that would take up additional labor.

PAINTED LADY will provide guest chairs and tables for up to 75 guests. Post event, all personal items and décor must be removed from outside areas used and from the event space the night of the event (if not renting entire property). Items to be picked up the following day by CLIENT(S) or rental companies may be placed in storage and pick up arrangements must be made with PAINTED LADY management.

PAINTED LADY will provide trash receptacles but is not responsible for cleanup. All trash and leftover food will be taken to the dumpster.

PAINTED LADY cannot provide outdoor lighting beyond what is currently existing. Please secure your own extension cords or A/V equipment.

# SCHEDULING FOR SETUP; DECORATING; DELIVERIES; VISITS, AND TEAR DOWN

PAINTED LADY operates a commercial business that necessitates scheduling of all on-site visits and/or preparations for your event. Commercial delivery arrangements must be made by CLIENT(S) in advance with PAINTED LADY. All visits to location prior to event date must be scheduled by appointment.

### UNATTENDED ITEMS/ADDITIONAL SECURITY

PAINTED LADY cannot ensure the security of items left unattended in function space. Special arrangements may be made with PAINTED LADY for securing a limited number of valuable items. If CLIENT(S) require additional security with respect to such items or for any other reason, the Client is responsible for making these arrangements.

### **PARKING**

Parking is available north of the property at Gorman Industries (1330 12th St NW) and also in the form of on-street parking. Street parking on Bellamah Avenue between 12th St and 8th St is permissible. We ask that you and your guests respect those living in the neighborhood by not blocking any driveways. No parking is allowed on any street except Bellamah Avenue. Please make sure guests are provided with parking information in invitation to events.

### **ALCOHOL**

PAINTED LADY controls all alcohol on the property. <u>Liquor (outside of specified beverages below) may not be sold or consumed on the premises</u>. Management will insist that anyone consuming alcohol not served by a certified server leave the premises immediately. Regulations below must be complied by Responsible Party renting the grounds as well as all guests attending the event:

- Licensed server provided by PAINTED LADY must be on site to serve and control alcoholic beverages on the grounds. If server should leave the grounds, bar will instantly be closed and all alcohol must be put away and no longer served to guests.
- Wine/cider/hard seltzer, beer & champagne are the only approved beverages that can be served.
- Any unapproved alcohol will be confiscated. Any additional beverages brought on the grounds at any time (which include spirits in a flask or otherwise) will also be confiscated.
- In addition, the server/owner/coordinator can stop service of alcohol at any time.



#### **SMOKING**

- Smoking and/or use of tobacco products of any kind are prohibited in ALL areas of Painted Lady Bed & Brew and its grounds.
- For guests that do smoke, it is allowed in a designated area at the west side of the property (front sidewalk) facing Bellamah Avenue only.

### **MUSIC**

PAINTED LADY is located on the outskirts of a residential area. The noise level must comply with the City of Albuquerque noise ordinance. Music outdoors must be kept to a level deemed reasonable by PAINTED LADY management. Speakers must be pointed in areas so as to not disturb neighbors. Bands/DJs must be willing to moderate volume – particularly bass levels – out of respect for neighbors. All music must end by 9:45 p.m. Please also note that the City of Albuquerque requires amplified music outdoors to cease at 10:00 p.m. in compliance with local noise restrictions.



### **DECORATIONS**

- No item may be hung without permission of PAINTED LADY.
- Decorations other than those that can be put on tables are allowed only with approval by PAINTED LADY, i.e. free-standing easels, columns, arches etc.
- Candles may be used but they must be in votive cups or some other type of candleholder. Tapers are not allowed.
- Candles are **not** allowed in lodging rooms.
- Rice or birdseed is not allowed on Painted Lady Bed & Brew grounds.
- Only real flower petals may be used OUTSIDE at Painted Lady Bed & Brew.
- No real flower petals can be used INSIDE property (Silk Petals are OK).

### **MISCELLANEOUS**

- Combination to exterior gates must not be shared with guests. CLIENT must manually open gates for approved guests or vendors.
- You may not sublease this contract to another renter.
- PAINTED LADY reserves the right to request and/or remove any person(s) that is damaging the property or otherwise not complying with the terms and conditions set forth in this agreement.
- Children need to be **CLOSELY** supervised at **ALL** times. Parents/Adults will be responsible for any damages caused by children.

### **IMPOSSIBILITY**

The performance of this Agreement is subject to termination without liability upon the occurrence of any circumstance beyond the control of either party – such as acts of God, war, government regulations, disaster, strikes (except those involving the employees or agents of the party seeking the protection of this clause), civil disorder, or curtailment of transportation facilities – to the extent that such circumstance makes it illegal or impossible to provide or use the facilities. The ability to terminate this Agreement without liability pursuant to this paragraph is conditioned upon delivery of written notice to the other party setting forth the basis for such termination as soon as reasonably practical – but in no event longer than ten (10) days – after learning of such basis.
